Pursuant to a letter of agreement dated September 15, 2020, with District Council 37 Local 1549-DSS/HRA/FIA/ACS/DHA Chapter the American Arbitration Association hereinafter referred to as the “Administrator,” agreed to conduct an Election of Officers.

Three Thousand One Hundred Forty-Six (3,146) ballot packets were mailed to eligible voters on Wednesday, October 28, 2020. District Council 37 provided the Administrator with a list of persons who were eligible to vote. The deadline to receive ballots was set for Thursday, November 12, 2020, at 9:00 AM. The Administrator received Four Hundred Fifteen (415) ballot packets prior to the reception deadline.
