Pursuant to a letter of agreement with District Council 37, Local 1549- PCT-SPCT, hereinafter referred to as “PCT-SPCT,” the American Arbitration Association hereinafter referred to as the “Administrator,” agreed to conduct a Re-Run Election of Officers.

One Thousand Four Hundred Forty-One (1,441) ballot packets were mailed to eligible voters on Monday, December 21, 2020. District Council 37 provided the Administrator with a list of persons who were eligible to vote. The deadline to receive ballots was set for Wednesday, January 7, 2021, at 9:00 AM. The Administrator received Two Hundred Seventy-Five (275) ballot packets prior to the reception deadline.

The tabulation of results took place after 10:00 AM on Wednesday, January 7, 2021, at the Administrator’s office, located at 120 Broadway, Concourse Level, New York, NY 10271. The secrecy of the votes were maintain at all times. The results are certified to be as follows:
