On November 4, 2021, AAA mailed 13, 273 to members to be returned at 9:00 a.m. November 29, 2021. Ballots were counted on Monday, November 29, 2021. 1525 ballot envelopes were returned and opened. Election results were delivered to members at the virtual General Membership meeting held on December 2, 2021 at 6pm.
